Boys & Girls Club of Chester Membership Rules

Read rules carefully. You will be responsible for all of them.

1. BGCC participants are expected to respect Club Rules, Club Staff, other members, and all Club property.
2. BGCC participants are not allowed to "hang out" in front of or behind the Club whether the building is open or closed.
3. BGCC participants are not allowed to leave the building without parental permission.
4. BGCC participants must use appropriate language at all times; derogatory language, cursing, teasing, "name calling", etc. is prohibited)
5. BGCC participants must demonstrate appropriate behavior; fighting, play fighting, pushing, grabbing, and throwing objects will result in **suspension**.
6. Use or possession of tobacco, alcohol, or drugs is strictly prohibited. ANYONE caught breaking this rule will be **suspended immediately and indefinitely**. His/her parent will be notified.
7. BGCC participants bringing weapons of any kind, including toy weapons will be **Suspended immediately and indefinitely**. His/her parent will be notified.
8. BGCC participants causing damage to club property will be **suspended** and responsible for restitution for all damages. His/her parents will be notified.
9. BGCC participants are **ONLY** permitted to have food and drinks in rec room and classroom areas. **Participants will be responsible for cleaning up trash.**
10. Any BGCC participant having problems with another participant should report the problem to staff immediately.
11. BGCC participants are not allowed to sell or trade on Club property.

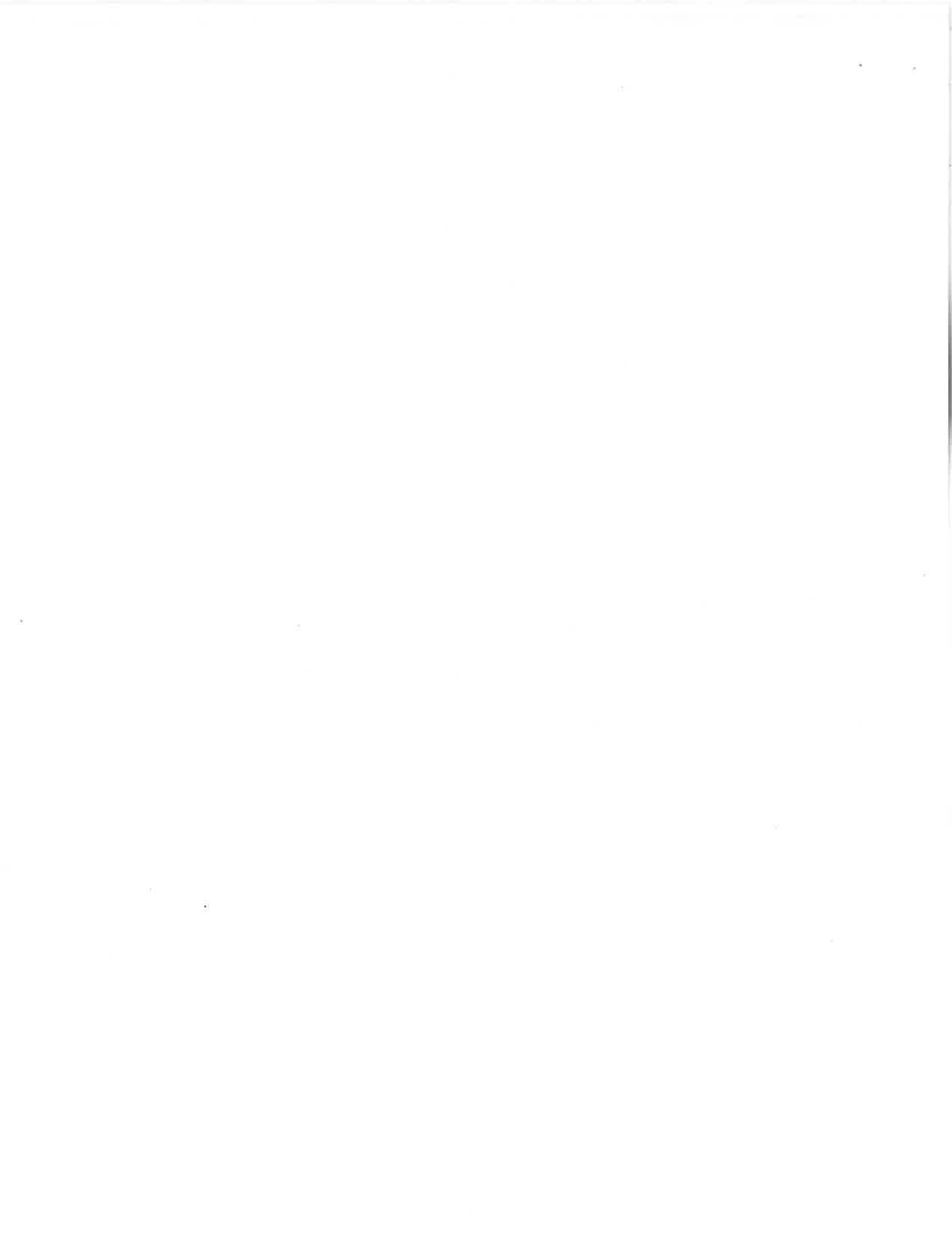
